## **BYOD & Acceptable Use of ICT Student Agreement**

Year 5 and Year 6 students must read and sign the BYOD Student Agreement in the company of a parent or guardian unless otherwise directed by the principal. Please return the signed copy to the office prior to bringing in any device to school.

I understand and agree that I will abide by Merewether Public School's BYOD policy and Acceptable Use of ICT Student Agreement, and that:

- I will use the school's internet services for learning.
- I will only use my device during school activities with teacher permission.
- I will use my own log-in details and will never share them with others.
- I will stay safe by not giving my personal information to strangers.
- I will not hack or bypass any hardware and software security implemented by The Department or my school.

• I will not use my own device to knowingly search for, link to, access or send anything that is offensive or inappropriate, threatening, abusive or considered to be bullying.

- I will report inappropriate behaviour and inappropriate material to my teacher.
- I understand that my activity on the internet is recorded and that these records may be used to review my actions.
- I will leave my device in the designated secure classroom space(s) when it is not in use.
- I acknowledge that the school cannot be held responsible for any damage to, or theft of my device.

• I understand that I must bring my device to school fully charged and in a carry case every day and that it is my responsibility to conserve battery by shutting down/sleep mode when my device is not in use. I will provide my own mouse, if laptop track pad is difficult to navigate.

• I understand that technical support at school is limited to school network needs. Teachers are not expected to resolve hardware or non-school or DEC recommended software issues.

• I have read the BYOD Student Responsibilities and agree to comply with the requirements.

• I have reviewed the BYOD Device Requirements and my device meets the minimum outlined specifications.

• It is my responsibility to back up my own data.

• I understand that inappropriate use of my device may result in loss of device privileges and disciplinary action.

• I acknowledge that any staff member has the right to inspect and confiscate devices if there are suspected violations of Merewether Public School's BYOD Policy and the Acceptable Use of ICT Policy, and this may result in suspension of internet access and device privileges.

• I understand that staff may confiscate devices until appropriate actions have been taken to ensure student wellbeing and disciplinary procedures have been completed.

## **Parent/Carer Agreement**
